



# Terms and conditions of the Dragon Balls Krakow Cup tournament

#### Definitions:

**Tournament** - a sports event, competition named Dragon Balls Krakow Cup organized by Dragon Balls Krakow Sports Club called Organizer (headquartered at 43 Czyżówka Street, 30-526 Krakow, Tax Identification Number 6793263624) operating in the form of an association.

**Organizing Committee** - the Board of Dragon Balls Krakow Sports Club and persons appointed by the Board on the basis of a Board resolution. The Board's resolution on the appointment of persons to the Organizing Committee also specifies the powers of these persons valid at the time specified in the resolution.

Player - a participant, a person registered for the tournament through the registration form.

**Registration form** - a panel on the Dragon Balls Krakow Sports Club website located at the specified link used to register teams that wish to participate in the tournament.

Captain - a person appointed by the registered team, this person represents the interests of the team.

## A. GENERAL RULES

- 1. The tournament is organized by the Dragon Balls Krakow Sports Club (headquarters: 43 Czyżówka St., 30-526 Krakow, Tax Identification Number 6793263624) operating in the form of an association, whose statute does not provide for the conduct of business activities, registered by the Office of the City of Krakow.
- 2. The Tournament will be held on July 13, 2024 in Krakow. The exact locations of the Tournament will be announced no later than 14 days before the start of the Tournament. - 3. The Organizer has appointed an Organizing Committee, which on his behalf will oversee the proper organization and course of the Tournament.
- 4. Persons playing are obliged to comply with these regulations. Acceptance of the rules on behalf of themselves and all entrants is made by the person sending the Registration Form.
- 5. The tournament is open only to teams that have registered through the Registration Form available at the following link: https://www.dragonballs.pl/join
- 6. Each team must consist of a minimum of 6 and a maximum of 10 players. It is not possible to register a team with an incomplete minimum lineup. Each team must designate a Captain and a team name.
- 7. Team registration is done by the Captain or a person designated by the team.
- 8. Registration remains valid after payment of the tournament fee for all entrants (see article B. TOURNAMENT FEES).
- 9. Team registrations confirmed by payment of the tournament fee (see article B. TOURNAMENT FEES) for all registered players may be canceled, but funds paid are

non-refundable. In accordance with the statute, unused funds within the payment made to the account of Dragon Balls Sport Club Krakow will be allocated to the statutory activities of the club.

10. Registration of teams for the Tournament is possible until June 15, 2024.

#### **B. TOURNAMENT FEES**

- 1. The Organizer of the Tournament sets the fees incrementally depending on the period in which the team registration is made.
- 2. The organizer sets the following stages of registration:

STAGE I: PLN 145 or EUR 45 per person in the period from January 15 to February 29, 2024;

STAGE II: PLN 160 or EUR 50 per person in the period from March 01 to April 30, 2024:

STAGE III: PLN 185 or EUR 55 per person in the period from May 01 to June 15, 2024

- 3. The tournament fee must be paid collectively for all players registered as part of a team through the registration form.
- 4. The tournament fee should be made to the account number indicated below and enter the details given below:

- 5. Team registration is valid only after payment in the amount applicable at the time of each stage, the date of receipt of funds to the organizer's account is decisive. Failure to make a payment or making an incomplete payment within 7 days of submitting the Registration Form will result in cancellation of the submitted Registration Form.
- 6. The tournament fee includes: welcome package for the players, participation in the tournament, lunch, snacks and drinks (on the day of the tournament), prizes for the players of the teams that take first, second and third places respectively at all levels, and an entrance ticket to the tournament party at the place designated by the Organizer.
- 7. The tournament fee does not include costs related to possible accommodation or expenses incurred for means of transportation and other costs not described in point 6 article B. TOURNAMENT FEES.
- 8. The organizer does not insure players against accidents for the duration of the tournament. Persons playing should make insurance on their own and at their own expense.

## C. RESPONSIBILITIES OF TEAMS AND PLAYERS

- 1. The team must have a Captain.
- 2. Teams of up to 10 people may participate in the Tournament.

- 3. The Tournament may be attended by persons without health contraindications to active sports.
- 4. Each Person playing takes part at his/her own risk.
- 5. Each Player is obliged to strictly follow the instructions of referees.
- 6. Persons playing are required to wear sports attire and indoor shoes.
- 7. Persons playing must be at least 18 years old.
- 8. Persons playing are obliged to observe the principle of sports rivalry "fair play".
- 9. In case of disputes, only the Captain has the right to clarify the incident or discussion situation with the first referee.
- 10. Players must comply with the provisions contained in the organizational notices and those given at the technical briefing, as well as other provisions relating to, among other things, the organization of facilities, locker rooms, stands, separated areas, the organization of the opening and closing ceremonies of tournaments and the announcement of results.
- 11. It is strictly prohibited to consume alcohol during the Tournament.
- 12. The organizer is not responsible for things left or lost in the sports facilities where the Tournament takes place.
- 13. Persons playing are obliged to familiarize themselves with the internal rules and regulations of the sports facilities where the tournament takes place and to observe these rules and regulations. Lack of knowledge of the rules and regulations does not relieve the person participating in the Tournament from liability resulting from failure to comply with these rules and regulations.
- 14. Players who do not comply with the provisions of these regulations may be excluded from the Tournament. The decision on exclusion shall be made by the Organizing Committee.

## D. TOURNAMENT RULES AND COMPETITION SYSTEM

- 1. The tournament rules and the tournament playing format will be made available to those playing no later than 14 days after the end of the third stage of registration (after June 15, 2024).

### **E. PROCESSING OF PERSONAL DATA**

- In accordance with the Regulation of the European Parliament and of the Council of the EU 2016/679 of April 27, 2016, we inform you that the administrator acquiring personal data is the Dragon Balls Krakow Sports Club, headquartered in Krakow 30-526, at 43 Czyżówka St. Contact with the administrators is possible via email at dragonballskrakow@gmail.com.
- 2. The purpose of processing personal data is to organize the Tournament. The basis for processing the data of the Playing Persons is the consent given by them for the processing of personal data at the time of sending the Registration Form.

- 3. The personal data acquired is the email address and first name, last name, as well as the image of the participants captured in photographs or videos of the Tournament in which the Playing Persons participated. In special cases and for the organization of other activities, the administrators may ask the Playing Persons to provide other data, such as full name, phone number and other data necessary for the proper implementation of a given event.
- 4. Data of Play Persons may be published in a way that other Play Persons can see it. In addition, photographs and video footage of the activity will be made available on Instagram and Facebook, as well as on www.dragonballskrakow.pl in a way that is visible to Persons playing and third parties.
- 5. The data will be processed until the end of the Tournament, for the purpose of participation in which they were made available, while the data in the form of images will be processed until they are no longer useful.
- 6. Each Playing Person has the right to access the content of the data, to correct it, the right to withdraw consent at any time, to request restriction of its processing, deletion and the right to be forgotten. - 7. Provision of personal data is voluntary, but is a condition for participation in the Tournament.
- 8. Any person whose data is processed has the right to file a complaint with the President of the Office for Personal Data Protection.
- 9. The data provided will not be subject to profiling.

For situations and occurrences not described in the Terms and Conditions of the Dragon Balls Krakow Cup tournament, the regulations applicable to the country in which the activities of the tournament organizer are registered shall apply.
